- 1. The Lao People's Democratic Republic (the "Borrower") has received financing from the Asian Development Bank (ADB) and the OPEC Fund in the form of a loan and from the Global Environmental Fund (GEF) in the form of a grant towards the cost of Vientiane Sustainable Urban Transport Project (VSUTP). Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The Department of Transport (DOT) of the Ministry of Public Work and Transport, (MPWT) Lao PDR (the "Employer") invites sealed bids from eligible bidders which meet the qualification criteria prescribed in Section 3 of the Bidding Documents for the Procurement of Works - Bus Lanes and Stations along the BRT Corridor from Patuxay to NUOL in Vientiane (the "Works"). Details and specifications are provided in the specified in Section 6 (Employer's Requirements) of the Bidding Documents. Completion of work period is within Twelve (12 months after award of contract. The Bid is for ONE complete Lot and for the associated works.
- 3. International Competitive Bidding will be conducted in accordance with ADB's Single-Stage One -Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding (Bidder shall furnish documentary evidence demonstrating that it meets the experience and financial requirements, which include):
 - a) Contractual Experience: Participation in at least one contract that has been successfully or substantially completed within the last five (5) years and that is similar to the proposed works. where the value of the Bidder's participation exceeds US\$ 10.0 million. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements),
 - b) Average Annual Turnover: The Bidder has a minimum average annual turnover of: USD 26.1 million; calculated as total payments received by the Bidder for contracts completed or under execution over the last five (5) years (2018-2022);
 - c) For Single Entities: The Bidder must demonstrate that its financial resources, less its financial obligations for its current contract commitments, meet or exceed the total requirement for the Subject Contract of USD 4.0 million. For Joint Ventures, see Section 3 of the Bidding Documents:

- 10. When comparing bids, ADB's Domestic Preference Scheme will not be applied in accordance with the provisions stipulated in the Bidding Document.
