The Ministry of Public Works and Transport (MPWT) and Ministry of Health (MOH) of Lao PDR have received financing support from the World Bank's (WB) through International Development Association (IDA) to implement the Scaling-Up Water Supply, Sanitation and Hygiene Project (SWSSHP or 'the Project') under IDA Cr. 6375-LA (WB Ref#. P164901). The project's Date of Effectiveness is 28 June 2019 with a project duration of 5 years until March 2024.

The objective of this assignment is for a full-time Administrative and Finance Assistant to the Project Management Unit of the Department of Water Supply of MPWT in the implementation of Scaling-Up Water Supply, Sanitation and Hygiene Project (SWSSH Project). She/he will be supervised by the Finance Consultant and of PMU management under DWS/MPWT. The total estimated inputs for this assignment are 4 months with annual renewal based on satisfactory performance review, this assignment expected to start by February 2024 on awards.

Interest Consultant shall provide information (CV, Expression of Interest, other supporting information, if any) demonstrating that she/he has the required qualifications and relevant experience to perform the Services. In order to qualify for this position, the candidates shall meet the following experience and competence requirements:

- 1. A bachelor's degree in accounting, finance or public/ business administration management, or relevant field.
- 2. At least 3 years of relevant continuous work experience in accounting/finance in similar position, .
- 3. Knowledge and experience of World Bank or ADB or major donors program administration procedures is highly desirable.
- 4. Familiarity with project administration and program management in government and foreign aided project operations.
- 5. Familiarity with National Treasury and Finance regulations of Ministry of Finance is desirable.
- 6. Ability to work independently and in a challenging environment to meet deadlines.
- 7. Fluent in both English and Lao languages (spoken and written)
