GENERAL PROCUREMENT NOTICE

The Government of Lao People's Democratic Republic (Lao PDR) has received credit financing in the amount of US\$25 million equivalent from the World Bank toward the cost of the Scaling-Up Water Supply, Sanitation and Hygiene Project (WSSHP), and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project.

The project will include the following components:

- 1. Delivery of Infrastructure and Sustainability of Water Supply and Sanitation**
- 2. Sustainability of Community Water Supply and Sanitation and Hygiene Support**
- 3. Implementation Support and Sector Development**
- 4. Contingent Emergency Response**

The procurement methods to be used for works will be RFQ and goods and non-consulting services will be RFQ, RFB (International/National) which is Establishment of bare minimum data center and backup facility for MIS, and for consultant will be individual consultant, quality and cost-based selection (QCBS) and selection based on consultant's qualifications (CQS) which includes Design, development and implementation of social and beneficiary integrated MIS, Payment agent for cash transfer, financial auditors, technical assistants, and project support staff.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's *Procurement Regulations for IPF Borrowers (July 2016)* (*Procurement Regulations*), and its current latest update of August 2018, and is open to all eligible firms and individuals as defined in the *Procurement Regulations*.
